

WUBE - COUNTRY CONCERT SWEEPSTAKES

OFFICIAL RULES

1. HOW TO ENTER: NO PURCHASE NECESSARY. There are two ways to enter this sweepstakes:
 - a. Website Entries. In order to enter, from 12:01:00 a.m. EST on Monday, May 22, 2017, through 11:59:59 p.m. EST on Sunday, June 18, 2017, log on to www.b105.com, click on the Country Concert/Dr Pepper image and complete the entry form, which includes your name, date of birth, telephone number and, at your option, upload a picture of someone enjoying summer with a Dr Pepper product. Once you have completed the entry form, click “submit” to be entered into the sweepstakes. The sponsors are not responsible for problems accessing the website or completing the entry, technical or atmospheric conditions that disrupt the completion of the entry, or any other problems which might or might not result from this sweepstakes.
